Greetings from BHEL-OHCS committee.

We are pleased to state that there was a very good response from our members towards payment of both maintenance charges and Club membership. We thank all the members who have already paid the Maintenance Charges and Club House Membership fees for their unstinted support, and confidence in BHEL-OHCS Committee. Many members and well-wishers of the Society have requested the Committee to further extend the timeline for payment of Maintenance Charges and Club Membership fee in view of the fact these are required for safeguarding the sites and ensure appreciation of value of sites. In view of this, the Committee has decided to extend the timeline for the aforementioned payments and accordingly, the last date for the said payment without interest is extended to 10th July 2022.

Accordingly, Society requests all those members who are yet to pay the Maintenance charges for the following period to pay on or before 10th July 2022 so as to ensure continued maintenance of the sites and layout and safeguard <u>and secure the sites of members from encroachment.</u>

Further, Members, who have already Paid for the maintenance charges for the period 01st January 2019 to 31st December 2020 are requested to pay the maintenance charges for the balance period from 01st January 2021 to 31st December 2022 on or before 10th July 2022. Members who have already paid for this period may kindly ignore this request since this message is intended for only those members who are yet to pay.

Members may please be note that in case the maintenance charges are not paid on or before 10th July 2022, interest @ 8% shall be charged to member from 01.01.2019 onwards up to the actual date of payment. Further, the Society shall not be responsible for the Safety and Security of the sites of such members.

Members may also note that the members who fail to pay maintenance charges will not be issued NOC from society till maintenance charges and interest calculated at rate 8% pa is paid for the period 01st January 2019 up to the date of issuing NOC.

We had received 14 offers for the above enquiry and status of offers received (L1, L2 & L3) is as below:

We would like to inform that our Society will not be able to operate with above quoted price, which is more than the estimate. (L1 price is more than Rs 3/sqft) Hence, this enquiry was cancelled with committees' approval. The society in order to ensure uninterrupted maintenance activities assigned the maintenance contract to M/s MSK shelters for one year from 01.01.2022 to 31.12.2022 by reducing the scope of work.

Presently, society is operating with limited scope for a short period, to manage the maintenance of the Layout. This maintenance is very vital for upkeep of the layout and to safeguard_and secure the sites of members from anti-social elements and encroachment from farmers.

Members are kindly aware that our layout needs continuous maintenance to safeguard and secure our investment and property. Members also aware that a well-kept and secure layout always appreciates well in terms of monetary value. Approximately 50% of the members have paid the maintenance and we request the balance members to pay Maintenance Charges and Club Membership fee during this extended date of payment.

However, we regret to inform Members, that due to nonpayment of maintenance from remaining members, society is unable to complete the pending development works. Hence, we request the members who are yet to pay the Maintenance Charges and Club Membership fee to pay the same on or before 10th July 2022 and so as to ensure that Members who have already paid the Maintenance Charges and Club Membership fee on time are NOT put in disadvantageous position.
